

## Focus on the Family Association Campaign

The North Dakota Family Alliance (NDFA) seeks to strengthen families, and protect our family values and religious freedoms. Our greatest hope is to impact the generational legacy we leave for our children and grandchildren.

The NDFA is a statewide, Christian based, non-denominational, non-partisan tax exempt entity seeking to inform the public and to influence public policy. On a state level, we attempt to do what Focus on the Family does on a national level. To become even more effective, the NDFA is seeking to become associated with Focus on the Family.

We see this association with Focus on the Family (FOTF) as a mutual benefit. The NDFA would be associated with a greatly respected national Christian organization. We would gain access to FOTF's high level of expertise, extensive research, and educational resources. We believe our sustainable revenue opportunities will be enhanced.
