# GENERAL INFORMATION

## **What is a voter guide?**

A voter's guide is a document to assist you as you prepare to cast your ballot in the general election on November 2<sup>nd</sup>. A series of questions were presented to legislative, congressional and statewide candidates and their responses are included in the guide.

## **How is the voter's guide used?**

To determine which candidates deserve your vote, respond to each question yourself. Compare your responses to the responses of those asking for your vote. Additionally, you may use the voter's guide as you personally visit with the candidates, getting more detailed responses to those questions of special interest to you.

## **Is the voter guide Democrat or Republican, or does it endorse candidates?**

It is factual, impartial, and nonpartisan. All candidates were given an equal opportunity to respond to the questionnaire. The voter's guide is an educational resource provided as a public service for your assistance as you prepare to vote, and does not endorse any candidate.

## **What was the process used?**

A questionnaire and letter of instruction was sent to all legislative, congressional and statewide candidates with a response deadline. If candidates wished, they could furnish additional written comments, which are available on our website at [www.ndfa.org](http://www.ndfa.org).

## **Why did some candidates not respond?**

We are not sure. All candidates received the same opportunity. For those without responses, we will share the candidate's official contact information, as filed with the Secretary of State's office.

**How do I find which Legislative District I live in?** Go to the Secretary of State's website, [www.nd.gov/sos](http://www.nd.gov/sos), contact your county auditor, or call the NDFA office at 701-364-0676.

## **Who paid for the Voter's Guide?**

NDFA, representing its constituents across the state of North Dakota, paid for the development, and distribution of the guide. No candidate or political party paid for the voter's guide.

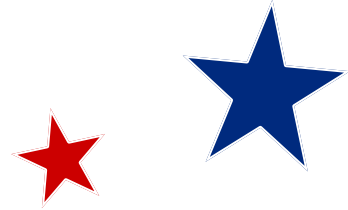

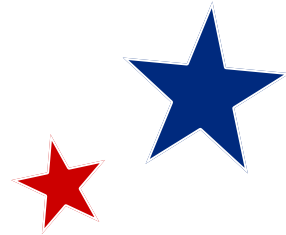
